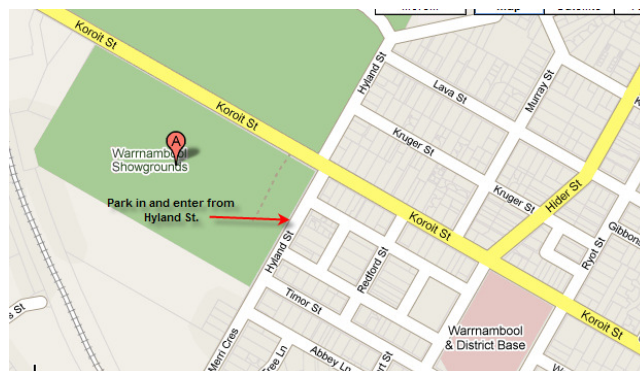

Conditions of Entry

This Show will be conducted under the Rules of the Australian Alpaca Association Ltd. as set out in the current AAA Ltd Showing Rules Manual and as detailed in this schedule. The General Regulations of the Warrnambool Agricultural Society, as appropriate, form part of these AAA Ltd. approved conditions of entry. In the event of any inconsistency between the General Regulations and these conditions, the General Regulations shall prevail to the extent of the inconsistency *unless the General Regulations provide otherwise.*

All exhibitors must ensure that they can comply with the conditions set out below before signing the entry form, particularly noting the condition dealing with animal health. A separate health declaration will be provided for signature and return with the entry form. Failure to sign the entry form will render all alpacas of an exhibitor ineligible to be exhibited. Please note that only the registered owner of an exhibit, or his/her authorised agent may sign an entry form. The registered owner of an exhibit must be a financial member of the AAA Ltd.

Entry declaration:

Submitting an entry to a Western Victorian Region show and signing the declaration on the entry form is an acceptance of the following statement:

1. I understand and accept that my entries in the Warrnambool Alpaca Show as appropriate will be accepted subject to the General Regulations and Conditions of those shows and I agree to be bound by all the Rules outlined in the current Australian Alpaca Association Showing Rules Manual and abide by all decisions in all matters in connection with or arising out of the competition
2. I certify that the details which I give on the relevant entry form or forms are correct.
3. I agree to make myself and others involved with the operation of my alpaca stud available to assist in the organisation and/or conduct of alpaca animal and/or fleece shows conducted under the auspices of the Victorian Western Region
4. I agree that no exhibit shall be exhibited unless from a herd or Stud/property for which either:
 - a) proof of accreditation under Alpaca Johnes Disease Market Assurance Program (AJDMAP) is provided or origin from a State recognised as Johnes Disease protected area, or
 - b) for non-assessed alpacas not originating from a State recognised as a Johnes Disease protected area, a signed declaration verifying that the exhibits have not at any period of their lifetime been in a herd or on a property where at any time Johnes Disease was known or suspected to exist.
 - c) The separate animal health declaration included with this Schedule must be signed by the exhibitor or his/her agent and returned with the entry form.

Alpacas travelling interstate must comply with that State's Department of Industry requirements.

Show organising and conduct

The organisation of a show involves a great deal of work. Many jobs/activities and roles have to be undertaken. To ensure that exhibitors share out these roles and activities equitably and don't leave the work to a few, all exhibitors must be willing and available to assist in regional show organisation and conduct.

By submitting an entry to a Victorian Western Region organised show, all exhibitors agree to participate in the work involved in organising and conducting VWR shows.

Exhibitors agree to undertake duties allocated to them by the show convener of any VWR organised show.

Period of Exhibition

Alpacas must be penned by 8:30am. Animals not present at this time may be disqualified by the Chief Steward

Pack-up and departure

All exhibitors are required to assist show organisers with the pack-up of all region provided equipment and facilities (including judging rings and related equipment, panels and pens etc) at the conclusion of judging and presentations at the direction of the Chief Steward.

No alpacas may be removed from the showgrounds on the day of the show before the Convener or Chief Steward has announced that exhibits may be removed from the show.

Preparation of Exhibits and Cleanliness of Stalls

Exhibitors must keep the stalls allotted to their animals clean, and give proper attention to their stock throughout the Show. Exhibitors must provide their own feed, and feed and water containers.

Advertising

Sale signs are not permitted. Stud names and general promotional material are permitted, but must be contained to the bounds of the pen and to a height of 1500mm at the rear of the pen. It is strongly recommended that no part of any signage be closer than 600mm to the floor of the pen to facilitate air circulation. Exhibitors must bring their own banners, poles ties etc.

Any promotional material attached to a pen must be kept clear of walkways.

Display of Show ribbons awarded at a Show held at another show is prohibited.

A handler shall be deemed to be incorrectly attired if his/her dress or the animal being led displays any information capable of being construed as advertising for any stud.

Companion animals and dogs

Special permission to bring a companion alpaca must be obtained from the Convener or Chief Steward prior to submission of the entry form, otherwise no companion alpacas will be permitted. No dogs are permitted into the precinct of where Show animals are being penned or shown in the ring. Guide Dogs are exempt.

Penning

All exhibitors shall, on the day of the Show, obtain their pen number and position and animal exhibit card numbers from the Shed Steward.

All exhibitors must place their animals in the pens allotted by the Show Stewards and animals may not be moved or removed except by order of the Chief Steward.

Inspection of Exhibits

All alpacas must be registered with the Australian Alpaca Association Ltd. and carry an approved brass tag showing the alpaca's IAR number.

A computer printout of the IAR pedigree registration record [ie from the IAR database] or a photocopy of both sides of the registration certificate for each alpaca must accompany this entry. No wether may have any visible genetic faults or visible physical disfigurement.

Persons appointed by the Convener as inspectors, shall inspect all alpacas for genetic faults, colour class and IAR number and visible physical disfigurement. The Inspector or Chief Steward will classify all entries for age, sex and colour and has the power to transfer an exhibit to the class which, in his/her opinion, it should have been entered. The Chief Steward will combine or split classes as he/she sees fit.

No animal shall be eligible for exhibition if it is not entire (except for wethers). All genitalia shall be complete, properly formed and proportioned for normal reproduction.

NOTE: If there is no IAR tag present in the ear of an animal exhibit, official Association confirmation must be provided by the owner to the Chief Steward that the ear tag has been recently lost and that a new tag has been ordered and paid for. Replacement tag orders and payments must be lodged with the National Office a minimum of one week before the date of the show. Failure to present such advice at inspection will result in disqualification of the animal.

The inspection of all alpacas will commence not later than 8:30am. Alpacas not in their allocated pens and available for inspection at the official time may be disqualified by the Chief Steward. Exhibitors must be in attendance at the time of the inspection and will be required to assist the Inspection Stewards and display animals teeth for inspection.

Exhibits of huacayas must carry a minimum fleece length of 50mm and a recommended maximum length not exceeding 130mm. The minimum fleece length for suris is 75mm and fleece length will be assessed by the Judge.

Exhibits shall not have fleece of a different colour to that of the blanket removed from an animal to a level below that of the blanket fleece.

Any alpaca found to have lice infestation must be removed from the showgrounds immediately along with any other alpacas present that belong to the same exhibitor.

Exhibitors' Meeting -Chief Steward

The Chief Steward requests that all exhibitors be available to attend a meeting in the show ring at 9:00am to be briefed on Show procedures.

Judging

Judging will commence from 9:30am.

A competitor may not discuss with the Judge their alpacas or proposed exhibits prior to, or during the Show judging.

The Judge's decision shall be final. He/she may choose not to award a prize or prizes in a class.

No person shall enter the judging ring after judging of a class begins, nor leave the ring until judging of the class has been completed and awards made except with the consent of the judge or at the direction of the judge or Ring Steward.

Dress code for handlers in the ring is a white coat over dark coloured long trousers or long skirts, with clean dark coloured dress shoes or boots. Hats are not permitted. The Chief Steward may disqualify an exhibitor for incorrect attire.

The handler of an exhibit in the judging ring shall remain with the exhibit until judging has been completed. While in the judging ring handlers must follow the directions of the judge(s) and/or ring steward. All handlers showing animals must be competent in the handling of their exhibit, or removal from the ring may be requested by the Judge. It is recommended that small children not exhibit large animals that they cannot control.

The animal exhibit number card of the exhibit must be worn and clearly displayed by the handler whilst in the show ring. The age of the alpaca and the age of fleece, in months, must be displayed on the card and, for females, whether pregnant or not.

Fleeces

All fleeces being exhibited (including wether fleeces) must be the bona fide property of an AAA Ltd. financial member and must be the bona fide property of the exhibitor – ie the owner of the alpaca at shearing.

Fleeces for **both or either** of the Warrnambool and/or Colac* shows are to be

- received by Mrs Lauris Jephcott at 3695 Colac – Lavers Hill Road, Ferguson by noon, Thursday 29 October or
- lodged with the Fleece Steward at the Warrnambool showgrounds by 8:30am on Sunday 1 November.

Only one fleece that has been shorn in the 18 months prior to the Show may be shown from any one animal. It is recommended that fleeces be placed in bags, made of satin or other suitable cloth, or heavy duty clear plastic.

Exhibitors, when submitting fleeces at the Show, must securely attach to the outside of the fleece bag the exhibit number supplied for that class (no names).

Correct Animal Colour Classification

An alpaca is to be shown in the appropriate colour class, when it is predominantly that colour. Any colour variations will be assessed at time of inspection.

Exhibits shall not have fleece of a different colour to that of the blanket removed from an animal to a level below that of the blanket fleece.

A fancy alpaca is to be shown in a fancy class if it has an unusual or striking distribution of colour e.g. different coloured saddle markings. A non solid coloured animal with different colour markings on the head, chest, or legs does not constitute a fancy alpaca. **A predominantly grey alpaca** (grey, rose grey/roan) is to be shown in a grey class, whether or not it has any other coloured spots present, and any colour variations will be assessed at the Judge's discretion.

Age of Alpaca

Alpacas must be entered into the correct class for their age (ie. age on the day of the Show unless otherwise specified).

Best & Supreme

Supreme and Best Colour Class.

Following the judging of entries in the Fancy and wether classes (if any), the Supreme Huacaya/Suri will be judged and, immediately following that judging, the Best Huacaya/Suri Colour Class. The Supreme Huacaya/Suri will automatically be adjudged the winner of its appropriate colour class and other colour classes drawn from the 1st place winners of respective age groups/colour classes, both male and female that have not been joined to other classes at that Show will be judged.

Sires Progeny Class

For the Warrnambool Show, the class requires two progeny by one sire. There shall be at least two entries in the sire progeny class before the class will take place.

A Sires Progeny entry cannot contain a wether, but may be a group of males, females or males and females. Progeny need not be owned or bred by the one exhibitor, but all must be the progeny of the one sire and drawn from ordinary classes. All progeny must have been entered as animal exhibits in the same Show as that in which they are to be exhibited as Sires Progeny.

Only one progeny from any one dam may be shown in each sires progeny group unless the progeny have been born at least eleven months apart.

Entry and entry fees for progeny group

Only one entry fee per group is required. The exhibit may be entered on the day of the Show before 12 noon or a time nominated by the Chief Steward.

Wethers

It is a requirement for wethers to be registered on the IAR to compete at AAA Ltd. run shows.

Protests

Only an exhibitor may lodge a protest against another exhibitor or a Show Official. The protest shall be lodged in writing together with a deposit of \$50, which shall be refunded if the protest is upheld. The sole grounds for a protest shall be a breach of the Show Rules.

Notice of protest shall be given to the Chief Steward within 10 minutes of the last alpaca being shown and the protest shall be formally lodged with the Chief Steward or Show Convenor, along with the deposit, within one hour of the end of the day's showing (when the last animal leaves the ring).

The Chief Steward or Show Convenor shall, prior to the commencement of the Show, establish a Protest Committee. The Committee shall comprise the Chief Steward as the Chair and two ordinary members. If an alleged incident occurred resulting in a protest in a class where the Chief Steward or other member of the Protest Committee was exhibiting or otherwise involved and his or her exhibit may have some bearing on the outcome of the protest then the Chief Steward or other member would stand aside and be replaced by the Show Convenor or another suitable member. A meeting will be convened within 30 minutes of the protest being received. The Protest Committee shall immediately investigate the protest and if found to be valid, initiate appropriate action.

Complaints against Judges are to be put in writing, within one week of the alleged incident, addressed to the AAA Ltd. National Secretary, c/- AAA Ltd. National Office accompanied by a \$50 fee, which will be refunded in the event that the complaint is upheld.

Huacaya Sections and Class Numbers

Depending on the number of entries and other considerations including inclement weather, the Show Conveners may decide that Suris be judged before Huacayas.

Huacaya 12 months & older must be shorn regularly so that no more than 15 months fleece is carried at the time of showing.

Under AAA rules, all classes over 20 animals are to be split evenly from youngest to oldest.
